Usoro ndubata Oke ruuru Afrika maka Mmadu na Oke ndi mmadu maka Oke Umunwaanyi n'Afrika, nke a maara dika Maputo Protokol, kwuru dika otu n'ime ngwa oke mmadu na-aga n'ihu n'uwa. Afrikan Union nabatara ya n'afọ 2003, o weputara nnukwu atumaatu maka ugwu, ikpeziriezi, na nwere onwe nke ndinne na umunwaanyi na mpaghara a niile. Maka imerime umunwaanyi o choro ichekwa, usoro a kariji ederede iwu. O bu nkwa.

N'ime nduzia e nwere Usoro abuo kacha puta ihe di: Ederede 5 kporo steeti ka o kpochapu omume ndi megidere mmadu dika ibi nwaanyi ugwu/ma o bu ibepu ihe nwaanyi, ilu di na nwata, na omenaala ndi ahụ megidere ahuike na ugwu ndinne na umunwaanyi; ezi nlekota nwaanyi n'afọime na mgbe o muchara nwa, ya na iteime n'usoro iwu kwadoro dika mgbe a kwasoro mmadu iko n'ike, mmeto, mmeko nwanne na nwanne, ma o bu mgbe afọime dowere uche na ahuike nwaanyi n'onodu ojoo.

Ederede ndia lebara anya n'ufodu iheimaaka umunwaanyi na-agabiga: igbochi onwu nwaanyi di ime ma o bu ka o muchara nwa, iteime n'usoro ezighiezi, aru dabeere n'odidi, na akparamagwa ndi na-afuufu ndi megidere unwaanyi inwe ikikere ichekwa ahụ ha. N'obodo nwere otu usoro iwu, iwu ndi ekwekoritara bu, n'ihe ndi no na ya, ndi e nwere ike itinye ozugbo ma ya akaria iwu obodo. Ma a ka ji ya eme ihe, abia n'iheomume, o na-ara ulokpe ndi nta na uloru ahụ itinye ukpuru ndia n'oru, hapu oghere n'agbata ihe ekwuru na ihe na-eme.

Usoro ndulatanulo a bu ngwa nduzi nke e mere maka otu di icha icha, ndiomeiwu na ndi na-akaiwu na-arụ oru iji kwalitekwuo nwelataulo Maputo Protokol na Naijiria. Naijiria nabatara ya n'abalị 16 nke onwa Dizemba 2024, Usoro a nyere Afrika Chata nke Human na Pipul's Raits ke umunwaanyi no n'Afrika.

Naijiria anabatala Maputo Protokol ma o nweghi ihe obula ha hapuru, kama iheimaaka, itinye ya n'oru gara n'ihu n'imegide umunwaanyị, nsopuru na nlekota idime na imunwa na nlekota iheodurude n'umunwaanyị. A ka chorọ nkwputa na ntuteghari n'Ederede 14, nke kwadoro oke nwaanyị nyere ahuike, nke gunyere mmeko na ahuikeomumu. iii

Nduzia lekwasara anya n'hiwe nkwputa maaka mmeko na ahuike omumu dika ibu nne n'enweghi nsogbu na ahuike ezinulo, ma gosiputa ihe ndi gbara okpurukpu iji mee ka iwu obodo na Maputo Protokol makoo iji chekwaa nke ahuru anya na nchekwa nke onwe nke umunwaanyị Naijiria. Ntuala nduzia lekwasara anya na atutu na ihe nleba anya otu mmekorita di iche iche, ndi na-ahu maka oke ruuru mmadu na ndi okachamaara otu iwu n'ekwuchiteonu. Naijiria nwerele onwe ya site n'aka Unaited Kingdom n'abali nke mbu nke onwa Okutoba 1960.iv

onuogugu ya kariiri nde 237.5, o bu otu n'ime obodo ndi nwere ubara mmadu n'uwa.v Naijiria nwere ngalaba ochichi ato: ogo ochichi etiti, ochichi steeti 36 na ochichi imeime obodo 774.vi Naijiria bu obodo iwu ochichionyekwuoucheya nke onyeisi na-elekota, ndi omeiwu nke ulomeiwu hiwere na ukpurukpe kwuru onwe ya. Ndiomeiwu kere uzo abuo, nke gunyere ndi Sineti na ndi Ulonnochiteanya.vii

Naijiria bu obodo nwere iwu mba uwa na iwu obodo dika ihe di iche, nke putara na Maputo Protokol anokataghi buru iwu site na nnabata ya. Iji nweta ezi uru na Naijiria, mpaghara Usoro ga-aburiri nke ewebatara n'ime iwu obodo site n'usoro nduzindubata. Naani iwu mbauwa e webatara n'iwu obodo ka e nwere ike itinye n'oru.viii Ruo mgbe e mere Maputo Protokol ya abanye n'iwu obodo, mbu di mkpa ya **niile banyere umunwaanyị inwere ikikere ahụ ha na oke mmadụ ka ga-abụ ihe a na-atụ anya ya.**

E nwere uzo di iche iche Usoro a nwere ike iji buru iwu obodo:

- Okara abuo n'ime uzo ato ndiomeiwu nwere ike kwadoo nkwekorita niile.
- E nwere ike rutu nkwekorita aka oge a na-eme iwu.
- E nwere ike iwere nkwekorita ahụ mere mgbakwasị ukwu n'ime iwu.

Ntuala iwu maka oke omumu

Iwu obodo Naijiria nke 1999 nyere ntuala mgbakwasị ukwu nke oke maka omumu nwere ike iji gaa n'ihu.^{ix} Isi nke IV kwadoro oke ndi ruuru mmadu, tinyere oke idi ndu (mpaghara 33), ugwu nke mmadu (mpaghara 34), idi ike onwe (mpaghara 350) nnozonwe (mpaghara 37) na nwereonwe site n'ikpaoke (mpaghara 42). Ihe ndia niile bu nke metutara nno okwu nwere onwe ahụ, ahụike omumu na nwereonwe site n'aru ana-akpa umunwaanyi

Nke ka mkpa, Mpaghara 34 manyere steeti ichekwa nchekwa na onoduma nke onye. Nke a ka e nwere ike gbatikwuo iji hu na e nwere nwere onwe ahụ na ugwu nwaanyi na Naijiria – nweta onoduma na nchekwa nke umunwaanyi n'uzo kari, belata aru ana-akpa n'ihie odidi, ibi nwaanyi ugwu/ibepu, ikpaoke site n'odidi na onwu nwaanyi di ime na nke na-amu nwa.

Kosiladi, e kwesiri imata ihe bu nno ogbachi: dika Isi nke II nke Iwu nyere steeti ntuziaka ka o hiwe ezigbo ulo nlekota ahuike di ichie ichie, ntuziaka ndi a abughi nke a na-ekpere ikpe. Usoro Iwu maka Aru

Naijiria ji usoro iwu abuo maka aru eme ihe, nke nwere mputara maka nwereonwe omumu. Na mpaghara Sawutu ke Naijiria, Kriminal Kod Akt machibidoro nno ihe onye choro maka ahumum, nye manye iga mporo afọ 14 maka iwepu afoime, ma hapu naani ohere ihe n'onodu di aña iji zoo ndu nwaanyi.^{xi} na mpaghara Ugwu Naijiria, Penal Kod Akt mere noo iteime aru nke a ga agara mkporo otutu oge; iji gbakwunyere, steeti 12 n'ala ugwu ji ulokpe Sharja na federal Penal Kod eme ihe, tinyegwaara mmachibido n'udi puru ichie.^{xii} Usoro abuo ndi a puru ichie otu e siri hiwe ha: Kriminal Kod etinyechaghi ya n'akwukwo maka oge ndu onye nne no n'oghom, n'agbanyeghi na okwu nke *Rex v Edgar na Rex v Bourne* weputara usoro kwadoro iteime n'onodu ndi di otu ahụ, ^{xiii} ma ha niile riri mperi n'ihie a choro n'okpuru Ederede 14(2)(c) nke Maputo Protokol.

Iwu ndi bu isi

Iji gbakwunyere Maputo Protokol, otutu iwu obodo na-akpuzi usoro iwu maka ikikere ahuike mmekohu na omumu na oke:

- Aru Megide mmadu (mmachi) Akt 2015 mere ka ikwasoikonike buru aru, aru ulo na ibi nwaanyi ugwu/ibepu. Kosila di, VAPP Akt bu naani na isi ala ka ana-etinye ya n'oru ozugbo . ka o wee ruo oru na steeti 36 nke Naijiria, steeti o bua kwesiri itinye ya n'oru.^{xiii}
- Oke Maka umunta Akt 2003 dowere afọ iji luo dinanwunwe ka o buru 18 ma machie imeto nwantakiri. Dika VAPP Akt, o kwesiri ka steeti tinye ya n'oru iji ruo oru na mpuga FCT.^{xv}
- Iwu Maka Ahuike Obodo nke 2014 nyere usoro maka nkwalite na nlekota ngalaba nke upuru ahuike, mee ka nlekota ahuike nke gunyere ahuikeomumu na nlekota uche, ma mee ka ulohuike nye nlekota n'oduru n'agbanyeghi ma e nwere ike ikwu ugwo.^{xvi}
- Iwu nke nchekwa ahuike 2022 (na-anochite iwu nke NHIS Ke 1999) weputara usoro nke iwu nchekwa ahuike kpuchitere uwa, tinyere mkpuchite nke omumu na nlekota ahuike uche niile.^{xvii}

I. Ọdịdị nke nduzinụlọ

Oganihu kemgbe edoziri ya

Naijiria azopula njem iji kwalitekwuo ikwanyere ndu ugwu na nchekwa nke onwe site n'igbakwunyetu ufodu Maputo Protokol n'iwu ime obodo, Tinyekwara n'atumaatu nke Ọdịdị nke anabatara n'afọ 2015.^{xxviii}, Kosiladi,

Itinye ya n'oru ka bu nke ezubeghi oke ma a chokuru igba mbọ iji webata iwu obodo ka o noro n'Usoro.

Ederede 3,4 na 5 nke Maputo Protokol kpokuru steeti di iche iche ka o chekwaa ndinne na umunwaanyi site n'aru. Otu site n'umunwaanyi ato Naijiria ga-enwe ahumihe ma o bu ikpa aru mmeko n'oge ndu ya. Na 2015, Naijiria tinyere Iwu VAPP, Nke chekubere igbochi aru na ndu nkiti na n'oha ma wete enyemaka nyere ndi loro aru mmekpaahu mmeko na aru ulo.^{xx} akwadoro iwu a ka afọ 14 gachara e jiri chunta.^{xxi} Na nwute, o bughị na stteti niile ka e tinyere ya, ma a ka nwere oghere digasi n'ilekota ndi dabara n'oghom aru. Sooso 19 n'ime steeti 36 hiwerele Senta iji kwadoo ma lekota ndi niile dabara n'oghom.^{xxii}

Ederede 5 nke Maputo Protokol na-arụ oru na Naijiria dika o machiri Ibi Ugwu/ibepu. Onugugu di nde 9.9 bu ndi loro oghom Ibe Ugwu bi na Naijiria, onugugu kacha ndi loro oghom n'uwa.^{xxiii} Naijiria elebala anya Ibi Nwaanyi ugwu n'ime Iwu VAPP na n'ime Atumaatu Obodo maka Ahuike,^{xxiv} ma webata atumaatu obodo nnoro onwe na atumaatu e ji eme ya maka mpka Ikpochapu Ibi Nwaanyi Ugwu 2021-2025.^{iv} Kaodi, Ederede 6 nke Maputo Protokol kporo oku ka ekpochapu ilu di na nwata. Na 2016, Naijiria nabatara atumaatu di iche iche iji belata Ilu Di na Nwata.^{xxvi} Kosiladi, a chokwuru otutu ihe iji chekwaa maka Ibi ugwu/ibepu, ilu din a nwata na alumi na mmanye, na ikpa aru ahụ. Anyi kwesikwara itule otu onodu a ga-esi metuta ndintoroobia Naijiria, ndi ga na-adoli na nweere onwe ahụ na aru n'ogbo oloro ohuru.

Ederede 9 nke Maputo Protokol poro oku ka umunwaanyi sonyekwuo na ndorondorochichi uwa na ikpebi ihe. Naijira Nashional Jenda Policy nyere umunwaanyi ohere ruru 35% iji sonye n'ochici ma o bu site n'inye okwa ma o bu nhoputa. 'xxvii Kosiladi, Naijiria no n'ogo ndi ka di ala n'umunwaanyi isonye n'ochichi n'uwa, naani oche 5% ka umunwaanyi ji n'uloomeiwu.^{xxviii} Iji dozie nke a, atumaatu maka umunwaanyi inweta okwa puruiche ga-ekewaputa oche ole umunwaanyi ga-anọ.^{xxix} Nnochite anya di oke mkpa n'ihu na umunwaanyi no n'isi atuteghariala otutu ihe nyere ahuike na iwu nchekwa.^{xxx} Iwelite onugugu umunwaanyi na ndiomeiwu ga-enye aka etinyechaa akaaku Maputo Protokol niile n'oru.

Oghere na Ogbachi

N'ihu na Naijiria etinyebeghi Maputo Protokol n'oru, oghere gara n'ihu noro n'etiti echiche Usoro na itinye ha n'oru, iwu ime obodo na ndu umunwaanyi Naijiria n'ebi. Idozi Usoro a bu nzopu njem di mkpa iji mata na ikwenkwa iji chekwaa oke umunwaanyi. Kosiladi, Nkwa a aputachaghi ihe n'iwu ime obodo, atumaatu ma o bu nlekota ahuike.

Oghere na Ogbachi Iwu na Atumaatu: Iteime na nlekota Uche

Naijiria nwere onugugu kariri akari n'onwu umunwaanyi n'ime na mgbe a na-amu nwa,^{xxxi} n'ikwebata ufodu aru ana-akpa umunwaanyi na mkpa o di inye umunwaanyi nlekota n'odurude. Iji belata ogo onwu umunwaanyi di ime na ndi na-amu nwa, obodo ahụ etinyela Atumaatu Njirimara maka iji Kpochapu Ori Mgbapu mamiri na Naijiria.^{xxxi} kosiladi, a ga-emekwu otutu ihe iji gbochie aru ana-akpa umunwaanyi ma mee ka e nweee nlekota ahuike di mma maka umunaanyi na imuna.

Oghere kacha n'iwu gbasra inwe ike iteime. E nwere ihe n'ezighi ezi n'etiti iwu Naijiria na nkwekorita ya n'okpuru ederede 14(2)(c) nke Maputo Protokol, nke choro ka steeti di iche iche nye nkwaodo iteime n'onodu nkwaso iko n'ike, nwakpo na mmekorita nwanne na nwanne na ebe afọime ahụ bu ihe oghom nyere uche na ahuihe nke nwaanyi. Ma nke Kriminal Kod Akt(a na-eme na South) ma o bu Penal Kod Akt (ana-eme n'Ugwu) nabatara onodu obosara a: ha niile machibidoro iteime n'usoro iwu nyere onodu di mkpa iji chekwaa ndu nwaanyi, nke nwere nnukwu ntaram ahuhu-ruo afọ 14 n'ulo mkporo-maka

umunwaanyi na ndi oru nnlekota ahuike ndi mere ihe n'adabereghi na nke a puruiche. Nke a dowere iwu Najjiria na mpaghara ndi kacha amachi ma ya na nkwenye maka oke ruuru mmadu ya a noro n'ogu.

Mmachi ndi a amitabeghi mkpuru n'igbochi iteime. N'ichikota ya onu otu n'ime afoime asaa na-ala n'iteime.^{xxxiii} Igbakota ya, 63% n'ime iteime ka emezighi emezi, nke wetere 10% n'onwu n'ime na imunwa. Ebe otutu ndiomeiwu ghotara na iteime n'uzo n'ezighi ezi na-ewete onwu onye nne.

Oghere toroto kpatara ihe isiike ndia. N'agbanyeghi na edoziri okwu Maputo Protokol na Dizemba 2004 n'ahapughi ihe o bula, etinyebeghi ya n'iwu obodo dika mpaghara ke 12 nke akwukwoiwu siri choo. Nke a putara na ihe niile Usoro weputara, tinyere Ederede 14, abughi nke a na-egosiputaihe n'ulo ikpe Najjiria di iche iche.^{xxxv} Oghere no n'agbata ochichi etiti na eweghi ike imejuputa ya na steeti bu otu: usoro oganihu ahuike a nabatara n'ogo etiti -nke gunyere VAPP Akt na iwu maka oke Nwa-bu nke nanoghi n'oru na steeti 36 nke Najjiria. N'ih na ahuike so n'ihe ndiomeiwu na-eleba anya, ndi nkwichite ga agbaghachi mbu n'ulomeiwu steeti niile iji mee ka anabata ma nye ego maka ya, ma keputa usoro kwesiri ekwesiri e nwere ike iji lebara iwu nchekwa nwaanyi anya site n'ebe o no.

Ihe Ohuru ndi Putara n'Iwu

N'agbanyeghi usoro mmachi a, 2025 wetere ukpuru ntuziaka nke nwere mputara puru iche maka atumaatu nkwichite. Na *Reproductive Justice Initiative Foundation (RJIF)* v Onyeisi Okwuchite Onu nke obodo gbaa gburugburu na ndi Ozo, ulokpe Ukwu no n'Abuja kuru na imanye ndi loro aru nkwaso iko n'ike ka ha buru afo ime gbaruru oke ruuru ha maka ahuike na uche.^{xxxvi} mkpebia, nochiri anya nnabata nke izizi a nabatara n'iwu ulo na nlekota ahuike maka ndi loro oghom ikwaso iko n'ike bu oke ruuru mmadu kariu iwu maka aru. Ndiokaiwu na otu nkwichiteonu di iche iche kwesiri ihu nkwenye a dika ntuala maka iga n'ihu weputa upuru mkpopuikpe na di ka akuru ngwa di ike maka asusu na nhazighari ihe ndi e jiri kporo mkpa.

Mmekoritaomenaala na Okpukperechi Oghere na Ogbachi

Iji wepatachaa Maputo Protokol n'iwu, ma o bu gakuwo n'ihu site n'iwu, okara abuo n'ime ato na ndiomeiwu n'ulo omeiwu ka a choo. Ka o di ugbo a, o nwere ike ndiomeiwu agaghi etinye iwu iji lebe ihe imaaka ndia anya, dika e riri mperi n'inwe mmasi na iji nlekota ahuike mmeko na ahuike omumu kporo ihe. ii

Mgbe o biara n'ihe ndi bu mkpa atumaatu, imirikiti ndi Najjiria bu ndi a na-eduzi site na nkwenye okpukperechi. Okpukperechi bu nke e ji ado ndorondoro nke ukwu na Najjiria, nke na otu okpukperechi di iche iche na ndi ndu imeime obodo na-aruru puru iche n'igbazi okwu na onodu atumaatu. ii Nke a emela ka e nwee ikpaoke n'ebe ogwumgbochiime na oke maka imu nwa no.ⁱⁱⁱ Mb o iji welitekwuo ohere iji nweta ogwumgbochiime ma o bu chekwaa ahuike mmeko bu nke nwere ogbachi.^{iv}

A gbaruru ihu, tumadi maka iteime, ma mbu agbarala iji tinye n'oru iwu ndi di mkpa maka iteime bu nke otu -ezinulo na otu steeti di iche iche katoto.ⁱⁱ

Mgbawwe atumaatu(akowara ya n'okpuru) di mkpa iji mejuputa Usoro a nke ukwu n'imaaka onodu ndorondoro a.

II. Nkwuputa na usoro atumaatu

E nwere uzo mbido abuo iji tinye Maputo Protokol n'iwu na Najjiria:

1. Site n'otu nkwichite na ndi na-ahu maka oke mmadu, iwu iji tinye ufodu ma obu Usoro n'oru bu nke abuo n'ime ato n'onuogugu ndiomeiwu ga-akwado.
2. Site na nkwichite sitere n'iwu na ntuteghari, mkpopuikpe ka e ji e weputa ukpuru iwu, kewaputa atumaatu ohuru ma dozigharia echiche oha.

Usoro ndi a metutara i ga n'ihu na ikwu ihe a choro, mgbanwe oru mmekorita na iwulite uche ndorondoro.

Otu Oha na ndi na-ahụ maka oke Mmadu

WRAPAⁱ worked with faith, religious and traditional cultural leaders between 2005 and 2017 to address the religious and cultural practices driving child marriage in north-western communities of Nigeria. Together, these stakeholders developed a Khutba, a compilation of sermons of the Prophet, that disproved some of the misconceptions contributing to early and forced marriage. The Khutba was then translated into local languages and used by traditional leaders. A total of 105 mosques used this Khutba during Friday prayers. By partnering with religious leaders to shift cultural norms, WRAPA has also been able to influence policy and legal reforms.
